Identification

Normeyes assigns you a "supplier code" that is used in all your electronic exchanges. Thanks to this code, available to all point-of-sale management software on the market, your catalogs are recognized. The "supplier code" consists of 3 letters. If your company has multiple entities that need to be distinguished, Normeyes provides an additional 2 letters, allowing you to have multiple codes. The additional codes are free of charge and are assigned in accordance with certain conditions.

Validation

As soon as your catalog contains a "supplier code," you, your clients, and your partners can verify its validity at no additional cost.

The Normeyes validator:

http://validator.edi-optique.org

is accessible online. It issues a validity certificate that confirms to everyone that your catalog meets the technical criteria of a compliant catalog, a requirement that is now standard for catalog distribution tools. Normeyes regularly enhances this tool to ensure the continuous improvement of your electronic catalog's quality. However, the validator obviously does not check whether your prices are appropriate, if the characteristics of your products are correct, etc.

Dematerialization

Would you like to reduce your administrative costs?

To achieve this, nothing is more effective than the dematerialization of invoices. The Normeyes vault directory allows you to know all the opticians who accept dematerialized invoices, as well as the address of the vault where you can deposit signed invoices.
